

Terms of Service

Thank you for choosing to use our services.

These Terms of Service (“Terms”, “Terms of Service”) govern your relationship with Menu-builder internet sites and online services (the “Service”) operated by Alexandros Paraskevopoulos Wifi-catalogue (collectively, “Wifi-catalogue” “us,” “we,” or “our”). Fee Changes

Chargeback / Refund Policy
